

COVID Indemnification Waiver

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. As a result, federal, state, and local governments and agencies recommend social distancing and other precautionary measures. Connect Camps is doing everything we can to be compliant with all regulations and ensure your safety. We have put in place preventative measures to reduce the spread of COVID-19, but we cannot guarantee that you or your family members will not become infected with COVID-19.

By participating in Connect Camps, you agree to the following:

On behalf of yourself and your children, you hereby release, covenant not to sue, discharge, and hold harmless Connect Camps, its employees, agents, and representatives, of and from all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating to your participation in Connect Camps. You understand and agree that this release includes any claims based on the actions, omissions, or negligence of this organization, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any hosted or programmed event by this organization.

Informed Consent, Authorization, and Release Agreement

Participation Authorization

I acknowledge that I have voluntarily enrolled my child in the Connect Camps day camp program ("Camp") facilitated by Connect Ministries, Inc. ("Connect") and local host churches and my child has my permission to take part in all Camp activities except as noted.

Medical Authorization

The health history that I have provided about my child is correct to the best of my knowledge. I consent to the first aid treatment of my child, including without limitation, the administration of over-the-counter medications to my child by an on-site nurse provided by the local host church. In the event of an emergency situation, I consent to my child receiving emergency medical or surgical treatment and hospitalization as necessary and I understand that Connect and/or local host church staff will attempt to contact me prior to taking such action. In the event that I, or the alternative emergency contact person, cannot be reached, I authorize medical providers to disclose my child's protected health information and/or Confidential Health Information to Connect and/or local host church staff, as well as any physician or health care provider involved in providing medical care to my child. I understand and agree that my child's health insurance shall be the insurance coverage for any medical treatment and that I will be financially responsible for any medical attention required by my child. I also understand and agree that if I do not have health insurance coverage or do not provide my health insurance information, I will still be financially responsible for any medical attention required by my child. Prescription medication should be sent in its original container from the pharmacy labeled with my child's name and administration instructions and I hereby authorize the on-site nurse to administer such to my child. I understand that my child should not be sent to Camp if he or she has a temperature of 100 degrees or higher.

Image Release

I hereby grant permission to Connect and the local host church the right to use, reproduce, and/or distribute photographs, films, videotapes, and sound recordings of my child, without compensation or approval rights, for use in materials created for purposes of promoting Connect's activities.

Release of Liability; Indemnification

In consideration of my child being allowed to participate in Camp, I acknowledge, understand, and agree that there are risks associated with my child's participation in Camp, and I, my child, and his or her other parent and/or legal guardian knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of Connect, the local host church, and their respective boards, directors, officers, employees, agents, and any other person or entity acting by or through such entities or individuals (collectively, "Releasees") and assume full responsibility for my child's participation in Camp. Additionally, I, on my own behalf and on behalf of my child, my spouse and/or my child's other parents(s) and/or legal guardian(s), as well as the heirs, successors, personal representatives, and assigns of the same, hereby release, indemnify, and hold harmless Releasees from and against any and all injury, disability, death, or loss or damage to person or property regarding my child arising from his or her participation in Camp, whether arising from negligence or pursuant to any other legal theory, except for willful misconduct, to the fullest extent allowable under applicable law.

Refund Policy Agreement

By proceeding with registering for the event, you acknowledge and agree that you have carefully read the agreement and waiver and agree to the terms set forth below.

In signing this agreement, you understand that a \$25 deposit is required for each camper in order to hold their position at Connect Camps. All deposits are non-refundable.

If you cancel your reservation more than 30 days prior to the camp start date, you will be refunded the total of all payments made minus the \$25 non-refundable deposit. If you cancel your reservation less than 30 days prior to the camp start date, you will be refunded half the amount of payments made minus the \$50 non-refundable deposit.

Coronavirus (COVID 19)

Connect Camps will refund a camper in full, excluding their non-refundable deposit, if that camper is not able to attend the full week of camp, due to COVID-19. If a camper attends camp but is unable to complete the camp week due to COVID-19, their refund will be prorated for their days at camp, excluding their non-refundable deposit.
